

Can I be in this program?

You should apply if you:

- Meet certain disability criteria
- Are a U.S. citizen or qualified alien
- Are 18-64 years of age
- Are employed
- Have countable income up to 300% of the federal poverty level
- Have resources of less than \$10,000 if unmarried and \$15,000 if married. (Certain retirement accounts are excluded from consideration.)

Employed Individuals with Disabilities (EID) Program

What is the Employed Individuals with Disabilities Program?



The Employed Individuals with Disabilities (EID) Program extends Medical Assistance health benefits to working Marylanders with disabilities.

Also known as the Medicaid Buy-In, this program lets you return to work and keep your health benefits by paying a small fee.

You can make more money or have more resources in this program than other Medicaid programs in Maryland.

What health benefits can I get?

All Medical Assistance services are covered. You can go to any fee-for-service Medical Assistance Provider. Services include but are not limited to:

- Inpatient and outpatient care
- Mental health services
- Physician and clinic visits
- Prescription drugs
- Personal care services at the home and work place

You can have Medicare or private health insurance benefits, and still be in the Employed Individuals with Disabilities Program.

What do I have to pay to be in the program?

For certain individuals, you can enroll for free. For others, a small fee of \$25 -55/month will be charged based on your income. If you are unable to pay the fee, you may request that the fee be waived.

How do I apply?

- a signed application
- verification of employment and income
- social security number
- proof of citizenship
- any necessary documentation to verify your resources or assets
